**NVBIA annual dues are not deductible as charitable contributions for federal income tax purposes. However, dues payments may be deductible as ordinary and necessary business expense, subject to exclusion for lobbying activity. Because a portion of your dues is used for lobbying by NAHB (\$20.02) and HBAV (\$49.60), \$69.62 will not be deductible for income tax purposes. \$72.50 of your NVBIA dues will be allocated to NoVa Build PAC to support candidates for the state and local elected offices who support the building industry. If you do not wish to have this portion of your dues allocated to NoVa Build PAC, you may do so in writing to NVBIA and \$72.50 will remain in the general fund. Payments for the NoVa Build PAC contributions are not tax deductible as charitable contributions for federal income tax purposes nor are they deductible as ordinary and necessary business expense. Your annual NVBIA dues include a \$50 voluntary donation to HomeAid NoVa a 501(c)3 charity. If you do not wish to donate this to charity please deduct \$50 from the total amount due.
